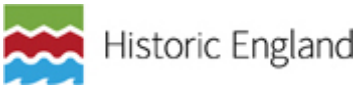

Since the Mordue case we've been working under that understanding that paragraph 206 is part of a fasciculus of paragraphs should be worked through, rather than each applied in isolation. If the Council, having carefully considered the viability report is content that a smaller, less harmful scheme would not be viable and thus the proposals need to be of the scale proposed in order to deliver the benefits claimed it would be reasonable to conclude that there is a clear and convincing justification for the harm.

Hi Richard

Hope you are well.

Please could I seek some clarification on your recent comments (attached) on the further revisions. You have previously advised (letter dated 24th January 2024 attached for ease of reference) that the proposals were edging closer to a point where you could accept that there is a clear and convincing justification for the harm, subject to further amendments to the design of blocks E and C (which you note could result in a meaningful reduction of the harm while still delivering the ambitions of the scheme).

As your recent comments confirm that the amendments address your key concerns about the architectural detailing of the scheme, do you therefore feel that we are at the point where you would accept that there is clear and convincingly justification for the scheme (as per your previous letter)? We would obviously take a robust approach to conditions regarding materials and detailing to ensure that the quality of the scheme is not compromised, and would consult HE on the discharge of such applications.

My opinion is that the whilst the scheme will result in less than substantial harm to the conservation area, this harm has been quite significantly reduced from the first iterations of the scheme (largely as a result of the reduction in height of blocks A and B and the now much improved architectural detailing of the street elevations). I am comfortable that the scheme is at a point where the harm is clear and convincingly justified (a smaller scheme would not be viable as demonstrated by the viability assessment), and the public benefits offered are such that they outweigh the harm (subject to further discussions regarding highways issues).

Your clarification would be much appreciated.
