The NDP refers to four landscapes in 5.6. Of these Chilton Park and Standen Manor are noted for their listed buildings but their grounds are important candidates as non registered historic parks and gardens in the Hungerford NDP area.

We request that Action C is reworded as follows:

ACTION C: IDENTIFY NON-DESIGNATED HERITAGE ASSETS
*Undertake a review of non-designated heritage assets (buildings **and parks and gardens** of heritage merit which are not nationally listed) and seek their addition to the West Berkshire Local List of Heritage Assets.*

We suggest that the NDP group include these two assets in any emerging study to identify non-designated heritage assets in the area.
